4A. Admission Process for In-House Pupils:

- After filling up the online admission form and making the payment for the form, the Administration Copy and the Teacher's Copy of the filled form and the Payment Receipt will be available in parent's enquiry login in Edusprint. **Kindly save and print them subsequently.**
- The Parental Consent Form and the Cancellation of Admission and Refund Policy needs to be downloaded from the school website under "Online Admissions".
- Shortlisted candidates will then be called for an informal interaction with the Principal and the HM. The date and time for this will be informed to the parents through an email from the school.
- The selected candidates will be intimated through an email to complete the admission process and payment of fees. The candidate's choice of subjects will be finalised based on the available vacancies as the admission confirmation will be given on a first come first serve basis.
- Parents of selected candidates will have to visit the school administration office with the hard copies of the completely filled Admission Form (Administration Copy and Teacher's Copy), the Parental Consent Form, the Cancellation of Admission and Refund Policy, Subject Selection Form and all the required documents for the payment of fees.
- Admission will not be given / will be cancelled if the documents are not valid and do not fulfill the eligibility criteria.
- Admission to Grade 11 will be treated as provisional till the receipt of a self-attested copy each of the Statement of Marks and the Pass Certificate of the Grade 10 Board Examination. The last date for the submission of the same will be one month after the declaration of the result.

4B. Admission Process for Pupils from Other Schools:

- The online Admission Form Fee is ₹ 1000/-(Non refundable).

- After filling up the online admission form and making the payment for the form, the Administration Copy and the Teacher's Copy of the filled form and the Payment Receipt will be available in parent's enquiry login in Edusprint. Kindly save and print them subsequently.
- The Parental Consent Form and the Cancellation of Admission and Refund Policy needs to be downloaded from the school website under "Online Admissions".
- Shortlisted candidates will then be called for an informal interaction with the Principal and the HM. The date and time for this will be informed to the parents through an email from the school.
- Parents are requested to carry hard copies of their ward's report card of the previous three years including the Prelim Report Card for the interaction.
- The selected candidates will be intimated through an email to complete the admission process and payment of fees. The candidate's choice of subjects will be finalised based on the available vacancies as the admission confirmation will be given on a first come first serve basis.
- Parents of selected candidates will have to visit the school administration office with the hard copies of the completely filled Admission Form (Administration Copy and Teacher's Copy), the Medical History Sheet with Stamp and Signature of the Medical Practitioner, the Parental Consent Form, the Cancellation of Admission and Refund Policy, Subject Selection Form and all the required documents mentioned below in point no. 5A or 5B for the payment of fees.
- Admission will not be given / will be cancelled if the documents are not valid and do not fulfill the eligibility criteria.
- Admission to Grade 11 will be treated as provisional till the receipt of the original School Leaving Certificate, the original Migration Certificate, a self-attested copy of the final report card from the previous school, a copy attested by the Principal of the previous school or a self-attested copy each of the Statement of Marks and the Pass Certificate of the Grade 10 Board Examination. The last date for the submission of the same will be one month after the declaration of the result.

6. Subjects Offered in Grade 11 and 12:

The following subjects are offered:

- (i) English-Compulsory
- (ii) Any one elective from Physics / Commerce / Geography
- (iii) Any one elective from Chemistry / Accounts / History
- (iv) Any one elective from Biology / Economics / Computer Science / Physical Education
- (v) Any one elective from Mathematics / Business Studies / Art / Psychology
- Note: (a) Pupils will have to select 4 electives from the choices given above. The subjects selected in Grade 11 will also have to be studied in Grade 12. Pupils cannot change the subjects in Grade 12. No changes in any subject will be permitted after 27th April, 2024.
 - (b) Pupils who opt for Computer Science and who did not have the subject in Grade 9 and 10 will have to appear for an entrance test of 25 marks based on the syllabus given below in point no. 7. They will be offered the subject only if they clear the entrance test, subject to available vacancies.

9. Cancellation of Admission and Refund Policy (ISC) 2024-2026:

- Admission Fees paid to the school will not be refunded under any circumstances.
- Those parents who wish to cancel the admission of their ward should give a written application signed by both the parents/ whoever signed the admission form, seeking cancellation of admission. The policy norms are mentioned below:
 - (a) If communication in writing for withdrawal is given to the School at any time on or before 31st March, 2024, then 100% Fee will be refunded (Except Admission Fee).
 - (b) If communication in writing for withdrawal is given to the School between 1st April, 2024 and 6th April, 2024, then 50% Fee will be refunded (Except Admission Fee).
 - (c) If communication in writing for withdrawal is given to the School at any time on or after 7th April, 2024, then fee will not be refunded.
- The school fee for the on-going academic year should be cleared, even if the student has not attended the school (online / offline), since the seat is occupied by the student. If the pupil has attended even one day in the months of April or October, then the parent is liable to pay the Term Fee for that term along with the Tuition Fee.
- The application for withdrawal has to be accompanied with an application for the refund of caution money signed by both the parents / whoever signed the admission form, along with the original caution money receipt stating the name in which the refund cheque has to be issued. The School Leaving Certificate and the Caution Money will be refunded to the applicant within 10 working days, from the receipt of the application / the last day attended by the pupil, whichever is later.
- Refund of Caution Money and the School Leaving Certificate will be issued only to those who have cleared the dues as mentioned by the school and the parents are requested to abide by the same.
- If the caution money receipt is lost / misplaced, then the applicant needs to submit an Indemnity Bond by paying a stamp duty of Rs.500/- duly notarised stating that he/she has lost the receipt. Parents should contact the school to understand the process for the same.
- The application for withdrawal of admission will not be accepted or processed during the vacation period.
- The Cancellation and Refund Policy should be accepted and signed by both the parents/whoever signed the admission form while securing the admission.
